OSFM & iLearn Facts

iLearnOregon facts to date:

- 44,598 users have accounts in the system.
 - ◆ **1306 from SFM**
- 5,001 users have actively used the system.
 - ◆ **61 from SFM**

Estimate cost avoidance for 2009-2011	Costs
Cost of instructor-led (live class)	\$624,000
Cost of self-paced eLearning	\$3,100 one-time costs
Total Savings (Statewide)	\$620,900
Estimated Carbon Emissions Savings (Statewide)	440,000 lbs

As of February 2009, OSFM has:

- Used iLearn to register personnel into 2 classroom courses, offered to all fire department personnel:
 - 1) Company Inspection Train-the-Trainer
 - 2) Fire Plans Examiner preparation
- Taught 2 iLearn Basic Trainings at OSFM ~ 19 employees trained
- Created 2 online tests:
 - 1) Basic Mechanical Code test: has been beta tested and is available for all fire departments online
 - 2) Over 600 tests to be administered in the near future

Future opportunities:

- Fire and Life Safety ~ Online courses
 - 1) Fire & Life Safety Awareness
 - 2) Basic Mechanical Code
 - 3) Basic Building Code
 - 4) Oregon Fire Code Amendment class

- License and Permits ~ Online testing of 13 different tests
- Community Right to Know ~ ORRS training, incident reporting, and online training
- Emergency Planning & Response Unit ~ iLearn provides the ability to have both public and private areas available to Oregon's Local Emergency Planning Committees in an effort to promote:
 - 1) Networking
 - 2) Sharing of individual LEPC information ~ projects and exercises
 - 3) Increasing communication and resources available to all Oregonians
 - 4) Opening a dialogue between various areas of the state ~ local to local
 - 5) Providing timely, update information
 - 6) Training and education
- All SFM units can communicate with outside agencies through collaboration spaces, blogs, uploading word and PowerPoint documents, announcements and reporting.

What is iLearnOregon?

iLearnOregon is the new electronic learning management system for OSFM. OSFM is using the system to manage all agency training records and course enrollments. All OSFM staff, fire department employees, and outside agencies have the ability to individually login and use iLearn to register, take courses and tests, create collaboration spaces and blogs, view announcements and upload documents. Additionally, individuals can access their transcripts.

Using iLearnOregon, managers can assign future training, content review (policies) and manage employees with the individual learning plan. The system has the ability to identify training needs linked to knowledge, skills, and abilities for job classifications.

How does iLearnOregon streamline processes and improve government efficiency? For the first time, the State can:

- Centralize all learning management functions and reporting; dramatically increasing the quality and accuracy of key agency and statewide training and development metrics, while decreasing the time associated with research and reporting
- Deliver and track online training
- Reduces training expenditures related to student/instructor related travel and facility costs.
- Increases the availability of staffing resources dedicated to other projects

iLearnOregon tools reduce training waste – offering training that is *just in time* and *just what is needed*.
